## Air Products Limited Warranty

### What is covered?

All Eclipse air mattresses are manufactured from the highest quality materials available. Every Eclipse air mattress shall be free of failures resulting from defects in materials or workmanship for the period listed below from the date of original retail purchase if used under normal circumstances. This warranty is provided to the original purchaser only.

This warranty is limited to repair or replacement of the defective Eclipse air mattress component, at the option of Eclipse, and any damages for breach of warranty due to consequential losses to property other than the defective Eclipse air mattress component is expressly excluded. In addition, all implied warranties are limited to the duration of this written warranty. This is the exclusive express warranty for this Eclipse air mattress and any other statements or express warranties are expressly denied. This warranty is void unless the Eclipse air mattress is used in accordance with instructions.

### What is the Coverage Period?

Eclipse warrants to the first purchaser only. The warranty starts with the date of original purchase. You must have your original purchase receipt to demonstrate original purchase date. Repair or replacement of any component will not extend the existing limited warranty, or begin a new limited warranty. Eclipse's obligation under this warranty shall be limited to the repair or replacement at our plant of any part or parts which prove defective within a period following the date of original purchase as outlined below.

\*Transportation costs to and from Eclipse are the responsibility of the purchaser. Please allow up to 90 days for performance by Eclipse under this warranty.

### Warranty Exclusions

This limited warranty specifically ***does not*** apply to:

Tears; punctures; excessive strain; mattress odor caused by bacteria; body impressions; discoloration or other environmental factors; any damage caused by improper use or improper installation; negligence; accidents; acts of god; failure caused by extreme temperatures; incidental or consequential damage; freight from/to consumer associated with repair or replacement; the entire Eclipse air mattress if sold as "floor model" or "as is".

This limited warranty does not cover defects caused by abuse, misuse, improper assembly, use with improper power supply, or inflation by means other than Eclipse air inflator.

Any apparently defective Eclipse air mattress must be returned to the dealer where it was purchased or to Eclipse at the purchaser's expense with the area in question clearly marked. A copy of the invoice or receipt of the original retail purchase of the air mattress must be included with the apparently defective Eclipse air mattress. Please allow 30 days for the performance of this warranty. Any product repaired or replaced under this Eclipse warranty does not carry a new warranty. The product is covered under the original warranty for the time remaining of the "no charge replacement period". The period is determined from the date of the original purchase.

This warranty gives you specific legal rights. You also have implied warranty rights. In the event of a problem with warranty service or performance, you may be able to go to small claims court, a State/Provincial court, or a Federal district court.
